1 As stated in the Court's August 9, 2024 Minute Order (Dkt. No. 330), Plaintiff's
2 Unopposed Motion for Preliminary Approval of Class Action Settlement (Dkt. No. 309) is
3 GRANTED.

4 Accordingly, as of August 9, 2024, the Court grants preliminary approval of the
5 settlement (as amended by the addendum submitted by Plaintiff on July 29, 2024, Dkt. No. 328).
6 The Court conditionally certifies the Settlement Class.¹ The Court appoints RG/2 Claims
7 Administration LLC as Settlement Administrator. The Court approves the Notice of Proposed
8 Settlement of Class Action Lawsuit (as reflected in Plaintiff's July 29, 2024 submission, Dkt.
9 No. 325) and plan of distribution. Accordingly:

- 10 • By Friday, August 16, 2024, Defendant's Counsel shall provide the Settlement
11 Administrator and Class Counsel with the Class list.
- 12 • By Friday, August 30, 2024, the Settlement Administrator shall send out the Notice to the
13 Class. Class Members shall have 60 days to object or opt out of the settlement.
- 14 • Plaintiff shall file his motion for final approval (and supporting papers) by December 24,
15 2024.
- 16 • Plaintiff's motion for final approval shall be heard on January 10, 2025, at 9:00 a.m., in
17 Department CX101.
